2. Current vehicle registration must be PRESENTED at the time stall is purchased.
3. Full payment for the entire lease year is due when the stall is purchased. (personal or certified checks or money orders No Credit cards.)
4. No Stalls will be sold prior to the dates listed above.
5. Mail Orders will be processed starting May 2018 you will need to enclose the following:
 - * Full annual permit cost, plus \$50.00 mail order processing cost. Payments must be made in Certified Check, Cashiers Check or Money Order only!
 - * Copy of current vehicle registration. Tenant(s) information name, phone #, complete apt address & parking lot address.
 - * Completed Mail orders may be signed & picked up by the tenant at the office at a later date.
6. Stalls may be purchased by a 3rd party if you are unable to be present.
 - * This will secure your stall, tenants will still need to sign & pick up permits at the office at a later date.
7. Non-Tenants can purchase parking at an increased rate of (\$200/yr) in addition to the cost for all of the stall locations.
8. Office hours for purchasing parking permits: Monday - Friday 10:00 AM - 4:00 PM.
9. When moving into the apartment, please:
 - * DO NOT PARK on lawns or in fire lanes.
 - * Please Do not park in any commercial stalls at 312 E Burlington St, Key West 417 S Gilbert St, Towers 333 S Gilbert St., Pentacrest Garden 19 E Burlington St, Mainstreet Apartments 327 E College St.
 - * Commercial tenants have the right to tow at any time during the year.
10. If moving into the apartment, after August 15th DO NOT PARK in the lot unless in your own stall.
